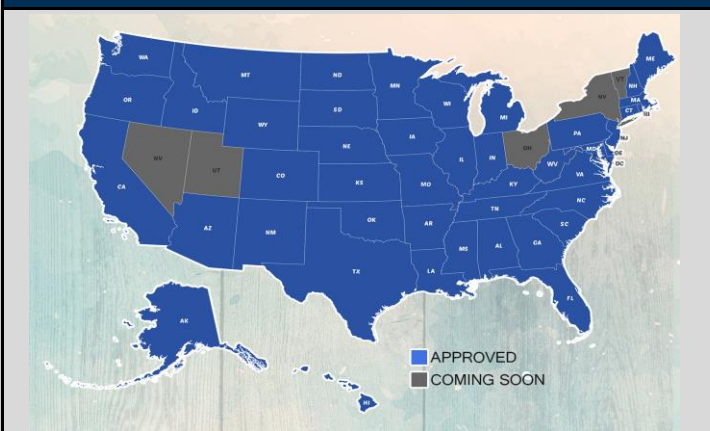
Lock Extensions
