**Lock Extensions**

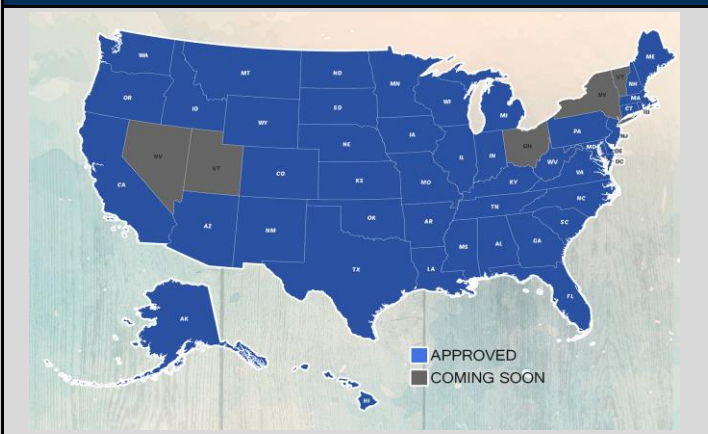
