Lock Extensions

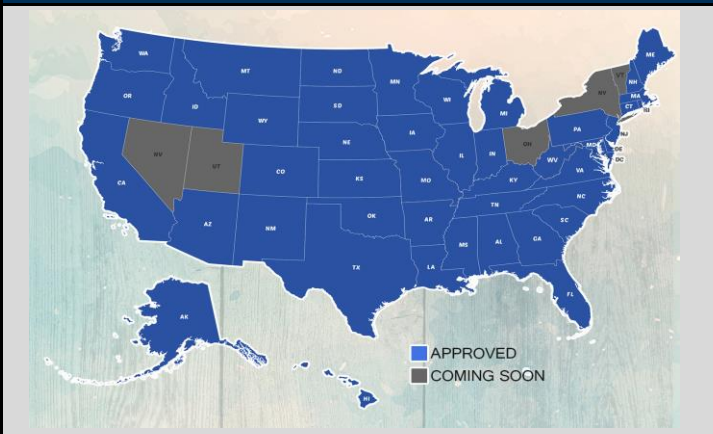

To be eligible for an extension, all extension requests must be received no later than 5:00 PM Central Time the day the lock expires.
