Lock Extensions

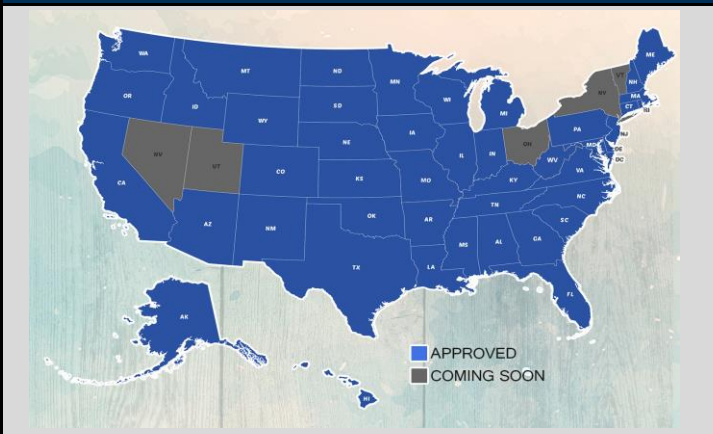
